The GSNI-M Bylaws and Policy Review Committee recommends 2 additions to the 2024 Bylaws of the Girl Scouts of Northern Indiana-Michiana. You can review the rationale on our website by scanning the QR code or visiting <https://bit.ly/4u7unXq>

Article IV Section 2 – Term of Office Add Subsection F.

F. Notwithstanding the foregoing provisions of this Section, the officers elected at the 2026 Annual Meeting shall serve a term of two (2) years or until their successors are elected and assume office. Thereafter, the term of office for officers shall revert to three (3) years as provided in Section 2.A. This amendment is being made to align the officers' terms with the terms of the National Delegates.

Article VIII - Section 4 – Board of Directors Add Section 9. Immediate Past Chair

The Board may also, in its discretion, appoint the past Chair of the Board as an ex officio member of the Board to serve a term of one (1) year. The Immediate Past Chair shall not have a vote and shall act solely in an advisory capacity to assist with the transition to the new Chair and provide advice to the board of directors on as needed basis. The Immediate Past Chair shall not be an elected position, shall not be counted toward the minimum or maximum number of directors-at-large required by these bylaws, nor toward the determination of a quorum, and shall not serve on the Executive Committee unless otherwise appointed in accordance with Article IX.
