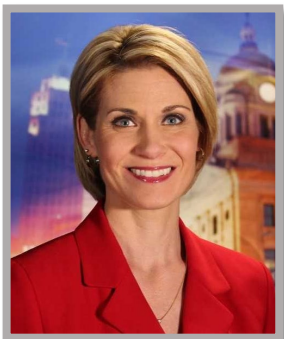
## Treasurer
